Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

(2) 根據《一手住宅物業銷售條例》第 52(1)條及第 53(2)及(3)條， -
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5% 的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

(3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第 8 條及附表二第 2 部的計算得出的。
The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

95% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.

(A1) 90 天 Super Lux 36 計劃 90-day Super Lux 36 Plan (照售價減 4%) (4% discount from Price)

- 成交金額 5%: 臨時訂金須於買方簽署臨時買賣合約時繳付, 買方並須於其後 5 個工作天內簽署買賣合約。
5% of the Transaction Price being the Preliminary Deposit shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase must be signed by the Purchaser within 5 working days thereafter.
- 成交金額 95%: 成交金額餘款須於買方簽署臨時買賣合約後 90 天內支付。
95% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.

(A2) 90 天備用二按貸款付款計劃 90-day Standby Second Mortgage Loan Payment Plan (照售價減 3%) (3% discount from Price)

- 成交金額 5%: 臨時訂金須於買方簽署臨時買賣合約時繳付, 買方並須於其後 5 個工作天內簽署買賣合約。
5% of the Transaction Price being the Preliminary Deposit shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase must be signed by the Purchaser within 5 working days thereafter.
- 成交金額 95%: 成交金額餘款須於買方簽署臨時買賣合約後 90 天內支付。
95% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.

(B) 210 天極靈活付款計劃 210-day Super Flexible Payment Plan (照售價減 7%) (7% discount from Price)

- 成交金額 5%: 臨時訂金須於買方簽署臨時買賣合約時繳付, 買方並須於其後 5 個工作天內簽署買賣合約。
5% of the Transaction Price being the Preliminary Deposit shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase must be signed by the Purchaser within 5 working days thereafter.
- 成交金額 5%: 加付訂金及部份成交金額須於買方簽署臨時買賣合約後 90 天內支付。
5% of the Transaction Price being further deposit and part payment of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.
- 成交金額 90%: 成交金額餘款須於買方簽署臨時買賣合約後 210 天內支付。
90% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 210 days after signing of the preliminary agreement for sale and purchase.

(B1) 210 天 Super Lux 36 計劃 210-day Super Lux 36 Plan (照售價減 3%) (3% discount from Price)

- 成交金額 5%: 臨時訂金須於買方簽署臨時買賣合約時繳付, 買方並須於其後 5 個工作天內簽署買賣合約。
5% of the Transaction Price being the Preliminary Deposit shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase must be signed by the Purchaser within 5 working days thereafter.
- 成交金額 5%: 加付訂金及部份成交金額須於買方簽署臨時買賣合約後 90 天內支付。
5% of the Transaction Price being further deposit and part payment of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.
- 成交金額 90%: 成交金額餘款須於買方簽署臨時買賣合約後 210 天內支付。
90% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 210 days after signing of the preliminary agreement for sale and purchase.

(B2) 210 天備用二按貸款付款計劃 210-day Standby Second Mortgage Loan Payment Plan (照售價減 2%) (2% discount from Price)

- 成交金額 5%: 臨時訂金須於買方簽署臨時買賣合約時繳付, 買方並須於其後 5 個工作天內簽署買賣合約。
5% of the Transaction Price being the Preliminary Deposit shall be paid upon signing of the preliminary agreement for sale and purchase. The agreement for sale and purchase must be signed by the Purchaser within 5 working days thereafter.
- 成交金額 5%: 加付訂金及部份成交金額須於買方簽署臨時買賣合約後 90 天內支付。
5% of the Transaction Price being further deposit and part payment of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the preliminary agreement for sale and purchase.
- 成交金額 90%: 成交金額餘款須於買方簽署臨時買賣合約後 210 天內支付。
90% of the Transaction Price being the balance of the Transaction Price shall be paid by the Purchaser within 210 days after signing of the preliminary agreement for sale and purchase.

An extra 4% discount from the Price would be offered to the Purchasers as the "Subsidy of Stamp Duty" Benefit.

(c) 路勁地產員工折扣 RK Properties Staff Purchasing Discount

If the purchaser is or includes a "Qualified Person of RK Properties", provided that the purchaser did not appoint any estate agent to act for him/her in the purchase of the specified residential property concerned, an extra 5% discount from the Price would be offered. "Qualified Person of RK Properties" means a director or employee of Road King Infrastructure Limited (or any of its subsidiaries), or his/her spouse or child. Provided That relevant supporting documents to the satisfaction of the Vendor to prove the relationship have been provided and the Vendor's determination as to whether there is such a relationship shall be final. The Vendor's determination as to whether a person is a "Qualified Person of RK Properties" shall be final.

(a) 首 3 年供息不供本 70% 第一按揭貸款 (此安排只適用於選擇(A1) 90 天 Super Lux 36 計劃 或 (B1) 210 天 Super Lux 36 計劃之買方。)

Interest only for the first 3 years of the 70% First Mortgage Loan (This arrangement is only applicable to Purchasers who choose (A1) 90-day Super Lux 36 Plan or (B1) 210-day Super Lux 36 Plan)

買方可向賣方介紹之財務機構或賣方指定的其它公司(「介紹之第一承接人」)申請最高達成交金額之 70% 之第一按揭(「第一按揭貸款」)。第一按揭貸款及其申請受以下條款及條件規限：

The Purchaser may apply to the financial institution referred by the Vendor or any other company designated by the Vendor (the "Referred First Mortgagee") for first mortgage with a maximum loan amount equivalent to 70% of the Transaction Price (the "First Mortgage Loan"). The First Mortgage Loan and its application are subject to the following terms and conditions:

(1) 買方必須於付清成交金額餘款之日起計最少 60 日前以指定格式的申請書向介紹之第一承接人申請第一按揭貸款。

The Purchaser shall apply to the Referred First Mortgagee for the First Mortgage Loan by the prescribed form not less than 60 days before the due date of payment of the balance of the Transaction Price.

(2) 買方須依照介紹之第一承接人之要求提供足夠之入息證明文件。

The Purchaser shall provide sufficient proof of income in accordance with the requirements of the Referred First Mortgagee.

(3) 買方須以所購之發展項目住宅物業之第一法定按揭作為第一按揭貸款的抵押。

The First Mortgage Loan shall be secured by a first legal mortgage over the residential property in the Development purchased by the Purchaser.

(4) 第一按揭貸款年期最長為 25 年。

The maximum tenor of the First Mortgage Loan shall be 25 years.

(5) 第一按揭貸款首 36 個月之年利率以介紹之第一承接人引用之最優惠利率(P)減 3.0% (P-3.0%)計算。其後之年利率以最優惠利率(P)計算。P 為介紹之第一承接人不時報價之港元最優惠利率，利率浮動，現為年利率 5.5%。最終按揭利率以介紹之第一承接人審批結果而定，賣方並無就其作出，亦不得被視為就其作出任何不論明示或隱含之陳述、承諾或保證。

The interest rate of the first 36 months of the First Mortgage Loan shall be Prime Rate (P) quoted by the Referred First Mortgagee minus 3.0% (P-3.0%). The interest rate for the rest of the term of the First Mortgage Loan shall be Prime Rate (P). P shall be the Hong Kong Dollar Best Lending Rate as quoted by the Referred First Mortgagee from time to time, subject to fluctuation. P currently is 5.5% per annum.
