  - The Purchaser shall provide sufficient proof of income in accordance with the requirements of the Referred Second Mortgagee.
- (3) 買方須以所購之發展項目住宅物業之第二法定按揭作為第二按揭貸款的抵押。
  - The Second Mortgage Loan shall be secured by a second legal mortgage over the residential property in the Development purchased by the Purchaser.

  - All legal documents of the second mortgage loan and its related guarantee(s) (if necessary) shall be handled by the solicitors designated by the Referred Second Mortgagee and all legal costs and disbursement relating thereto shall be borne by the Purchaser(s) and his/her/their guarantor(s) (if any).
- (10) 買方於決定選擇此安排前,請先向介紹之第二承按人查詢清楚按揭條款及條件、批核條件及申請手續。
  - The Purchaser is advised to enquire with the Referred Second Mortgagee on details of the terms and conditions of the mortgage, approval conditions and application procedures of the Second Mortgage before choosing this arrangement.
- (11) 第二按揭貸款條款及批核條件僅供參考,介紹之第二承按人保留在其認為合適時不時更改第二按揭貸款條款及批核條件的權利。
  - The terms and conditions and approval conditions of the Second Mortgage Loan are for reference only, the Referred Second Mortgage reserves the right to change the terms and conditions and approval conditions of the Second Mortgage Loan from time to time as it sees fit.
- (12) 第二按揭貸款受其他條款及細則約束。有關第二按揭貸款之批核與否及借貸條款以介紹之第二承按人之最終決定為準,與賣方無關,且於任何情況賣方均無需為此負責。賣方並無或不得被視為 就第二按揭貸款之按揭條款及條件以及申請批核與否作出任何不論明示或隱含之陳述、承諾或保證。不論貸款獲批與否,買方仍須按買賣合約完成交易及付清成交金額餘款。
  - The Second Mortgage Loan is subject to other terms and conditions. The terms and conditions and the approval or disapproval of applications for the Second Mortgage Loan are subject to the final decision of the Referred Second Mortgagee, and are not related to the Vendor (who shall under no circumstances be responsible therefor). No representation, undertaking or warranty, whether express or implied, is given, or shall be deemed to have been given by Vendor in respect of the terms and conditions and the approval or disapproval of applications for the Second Mortgage Loan. Regardless the Second Mortgage Loan is granted or not, the Purchaser(s) shall complete the sale and purchase and pay the balance of the Transaction Price in accordance with the agreement for sale and purchase.
- (13) 買方須就申請第二按揭貸款支付港幣\$5,000 不可退還的申請手續費。
  - The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the Second Mortgage Loan.
- (14) 買方如於下列時間內付清第二按揭貸款金額,該買方可根據以下列表獲介紹之第二承按人送出現金回贈優惠(「提前付清第二按揭貸款金額現金回贈優惠」)。

If the Purchaser settles the Second Mortgage Loan within the period specified below, the Purchaser shall be entitled to an early settlement benefit ("Early Second Mortgage Loan Settlement Benefit") offered by the Referred Second Mortgagee according to the table below.
